

Must hold one of the following

- Group 1
 - A valid visa from the USA
 - An old/expired Canadian visa held in the past 10 years
- Group 2
 - A valid green card from the USA

Additional rules


- Applicable to air travel only
- Must apply for Electronic Travel Authorization (eTA) before arrival

Entry granted

- Up to 180 days

Mexico

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A valid Schengen visa
- A valid visa or residence permit from Canada, Japan, any Schengen country, UK or USA
- A residence permit from Chile, Colombia or Peru

Additional rules


- The visa must be valid during the entire stay in Mexico
- Passport must be valid during the entire stay in Mexico

- Up to 180 days

Chapter 2: CENTRAL AMERICA



Belize

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A valid Schengen visa
- A valid visa or residence permit (green card) from USA
- A valid residence permit from any EU country

Additional rules

- Visa must be multiple-entry

Entry granted

- Up to 30 days

Costa Rica

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A visa or residence permit from Canada or USA
- A residence permit from any EU country

Additional rules


- For B1/B2, C1 and D visa from the USA and multiple entry visa from Canada, it must be valid for at least 1 day from the day of arrival
- For work visa, student visa or green card from the USA, it must be valid for at least 6 months from the day of arrival
- For residence permit from any country in the EU, it must be valid for at least 6 months from the day of arrival

- Up to 30 days

El Salvador

Applies to the following passport holders only

- India

Must hold one of the following

- A valid Schengen visa
- A valid visa from Canada or USA

Additional rules

- Must enter El Salvador by land from Guatemala. Unrestricted travel between the CA-4 countries (Guatemala, Honduras, El Salvador and Nicaragua) by land is allowed as per Central America-4 Border Control Agreement.
- Must enter Guatemala first on visa exemption and travel to El Salvador (or any of the CA-4 countries) by land.

- India

Must hold one of the following

- A valid Schengen visa
- A valid visa from Canada or USA

Honduras

Applies to the following passport holders only

- India

Must hold one of the following

- A valid Schengen visa
- A valid visa from Canada or USA

Additional rules


- Visa must be valid for at least 6 months from the date of arrival
- Must enter Honduras by land from Guatemala.
Unrestricted travel between CA-4 countries (Guatemala, Honduras, El Salvador and Nicaragua) by land is allowed as per Central America-4 Border Control Agreement.
- Must enter Guatemala first on visa exemption and travel to Honduras (or any of the CA-4 countries) by land.

Entry granted

- Up to 90 days

Nicaragua

Applies to the following passport holders only

- India

Must hold one of the following

- A valid visa from Canada, Schengen or USA (If entering by land from CA-4 countries)
- A valid visa from the USA (If entering by air or by land from Costa Rica)

Additional rules

- Visa is NOT EXEMPT, but are eligible to avail VoA for a fee of \$50 USD (payable in USD only)

Entry granted

- Up to 30 days

Panama

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A multiple-entry visa from Australia, Canada, UK or USA
- A residence permit (green card) from the USA

Additional rules


- Visa must be valid for at least one year from the date of arrival
- Visa must have been used at least once to enter the country of visa
- Passport must be valid for at least three months
- Must show proof of economic solvency for a minimum of \$500 USD



Must hold one of the following

- Group 1 (All nationalities)
 - A valid multiple-entry Schengen visa
 - A valid multiple-entry visa from Ireland or UK
 - A valid residence permit from Canada, Ireland, any Schengen country, Switzerland, UK or USA
 - A valid residence permit from Caribbean part of the Netherlands (Aruba, Bonaire, Curaçao, Saba, St Eustatius and St Maarten)
- Group 2 (Bolivia, China, Cuba, Dominican Republic, Guyana, Haiti, India, Jamaica and Peru)
 - A valid multiple-entry visa from Canada or USA



Additional rules

- If holding a residence permit from Caribbean part of Netherlands (Aruba, Bonaire, Curaçao, Saba, St Eustatius and St Maarten), the residence permit must entitle you to stay for at least 6 months.

- Group 2
 - All nationalities

Must hold one of the following

- Group 1 (Jamaica and China)
 - A valid visa from Canada, UK or USA
- Group 2 (All nationalities)
 - A valid residence permit from Canada, UK or USA

Additional rules

- Must arrive directly from country of visa or residence permit
- Example: If holding a UK visa, must fly into Cayman Islands directly from the UK

 - Authorized Airlines
 - Travel Agencies

 - A valid residence permit from Caribbean part of the Netherlands (Aruba, Bonaire, Curaçao, Saba, St Eustatius and St Maarten)



- Residence permits, work/student visa are not eligible
- The visa must be valid for at least 6 months

- Up to 90 days

Applies to the following passport holders only

- China

Must hold one of the following

- A valid Schengen visa
- A valid tourist visa from USA

Additional rules

- The visa must be tourist visa (B2 or B1/B2) only
- Residence permits, work/student visa are not eligible
- The visa must be valid for at least 3 months from the day of entry into Argentina
- Must apply for Electronic Travel Authorization (ETA) before arrival



Chapter 5: EUROPE



Albania

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A valid Schengen visa
- A residence permit from any Schengen country
- A valid multiple-entry visa or residence permit from the UK or USA

Additional rules

- Must have used the visa to enter the visa issuing country at least once

Entry granted

- Up to 90 days

Andorra

Applies to the following passport holders only

- All nationalities

Must hold one of the following

- A valid Schengen visa
- A residence permit from any Schengen country

Additional rules

- Andorra doesn't require any visa, but entry/exit to Andorra is only through Spain or France which requires a Schengen Visa
- Schengen visa must be multiple-entry or at least double-entry as the entry/exit to Andorra is only through Schengen zone

Additional rules

- The visa must have been used at least once
- Must enter and exit through Minsk National Airport only



- The visa must be valid for at least 30 days from the date of entry



Must hold one of the following

 - A valid multiple-entry visa or residence permit from the UK
- Group 2 (China, India, Mongolia, Morocco, Russia)
 - A valid multiple-entry Schengen visa

Additional rules

- Multiple-entry Schengen visa must have a remaining validity of at least 7 days on the day of departure from Gibraltar.
- UK multiple-entry visas must be issued for at least 6 months or more
- UK residence permits must be issued for at least 12 months or more

Entry granted

- Up to 21 days (Schengen visa)
- Up to 180 days (UK visa)

- Must enter Ireland within the exit date on your UK entry stamp (this is different than visa expiry date)

Macedonia

Must hold one of the following

- A valid Schengen visa
- A valid visa from Canada, UK or USA
- A valid permanent residency in any EU country or Schengen country

Additional rules

- The visa must be valid for at least 5 days beyond the intended period of stay
- Total duration of consecutive stays must not exceed 3 months in any 6 months period

Entry granted




